Local Authority Building Control - UPDATE

To whom it may concern,

It is with regret that after a 17-year relationship, we announce from May 2022 Jackpad will no longer be part of the LABC Registered details (Assured) scheme. Following a review, Local Authority Building Control have taken the decision to remove this scheme from the services it provides.

Its disappointing that through circumstances beyond our control our relationship with Local Authority Building Control has come to an end. In the early days especially, the LABC stamp gave real credibility that Jackpad was a serious alternative to concrete foundations, and the system would do just what it said on the tin. We've come along way as a company during this time, having successfully supported thousands of modular buildings across the country for leading modular manufacturers, main contractors and end users, Jackpad continues to be the name synonymous with sustainable foundations.
